PAY NO ATTENTION TO THOSE THOUSAND SUICIDES A DAY.

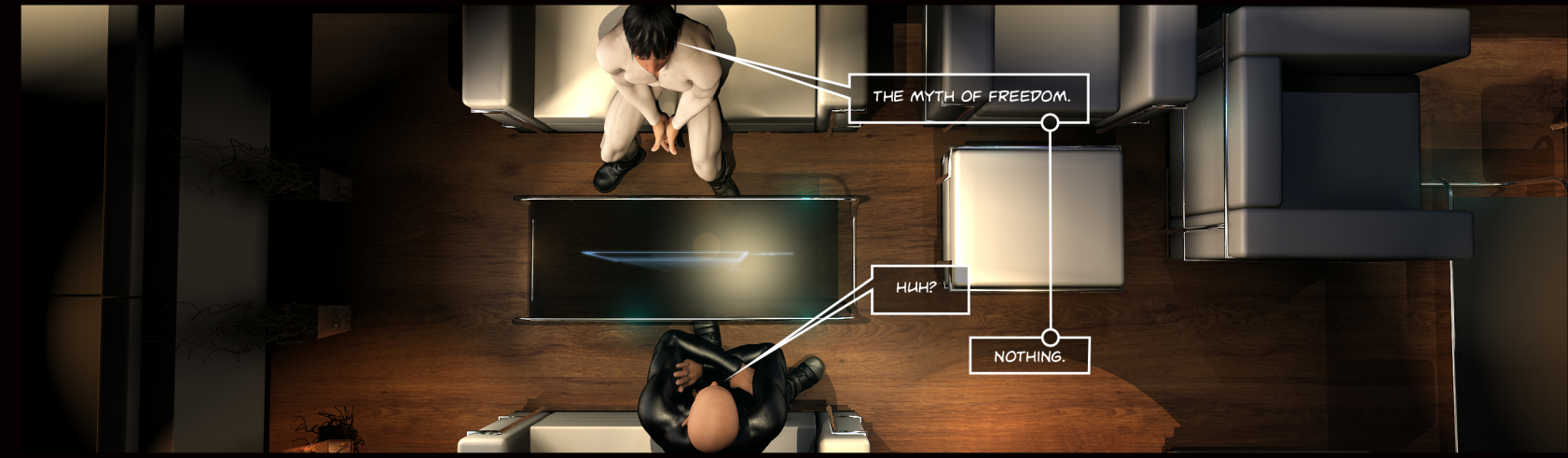
